STEP 1 OF 4

Installing the Clamp

This clamp fits bars and pipes from 1/2 Inch to 1 1/2 Inch. To installed, loosen the included thumb screw and place the lamp around the bar.

Use the included thumb screw to tighten the clamp, then flip the thumb screw down to tighten the clamp and prevent it from loosening.



STEP 2 OF 4

Adjust the Quick Release Dock Angle

Using the ring below the Quick Release Dock, you can loosen the dock and adjust the angle. Once the desired angle is achieved, tighten the ring again to keep the quick release dock in the preferred angle.



STEP 3 OF 4

Docking

This clamp kit supports Tilt/Swivels as well as Quick Release Docks. To install a holder or dock, simply slide the short side down and into the dock to lock it into place.



STEP 4 OF 4

Undocking

To remove the docked device, you need to depress the 15mm release arm located on the top of the quick release dock. This arm prevents the device from accidentally sliding out.

Remove the device by pressing the release lever slightly and then sliding straight up and over the release tab.

Returns
