STEP 1 OF 8

Remove battery from printer. Insert swivel ball into attachment port at bottom of battery compartment.



STEP 2 OF 8

Swivel the plate down temporarily and put battery back into place to secure swivel ball.



STEP 3 OF 8

Swivel the plate into place to cover the battery and secure using the enclosed screws.



STEP 4 OF 8

Attach the Quick Release Dock to your mounting position using the appropriate hardware for the location.

Insert printer with attached plate into the Quick Release Dock. Press release tab and slide printer out to remove.



STEP 5 OF 8

Using the pedestal as a template, mark pilot holes for your fasteners.

Drill pilot holes using the proper bit. For self tapping screws, use a drill bit slightly smaller than the screws. For machine screws with a nut, use a a drill bit slightly larger than the screws.



STEP 6 OF 8

Align the pedestal base with the pre-drilled holes and attach using the proper screws for your surface material.



STEP 7 OF 8

Use the lower wingnut to tighten the pedestal arm into the desired position.



STEP 8 OF 8

Use the upper wingnut to tighten the pedestal face into the desired position.

Returns
