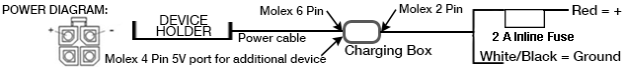


DO NOT attach anything to the mount face plate until after installing the mount to the dashboard. Doing so makes it more difficult to install the mount to the dash.

STEP 1 OF 8

To attach the pedestal:

Find a good mounting position on your dashboard. Make sure you can get access from behind (to attach the backing plate) by removing the necessary dash panels. Ensure there are no wires behind the mounting spot.

Using the pedestal as a template mark the holes on the dash, or dash panel as shown in picture. Then drill the holes large enough for M4 screws to go through.



STEP 2 OF 8

Line up the pedestal and the backing plate with the drilled holes. Secure in place using the enclosed screws and locking nuts.



STEP 3 OF 8

To mount the cradle:

To mount the cradle WITH the Tilt-Swivel; undo the center screw on the cradle. Remove the Tilt-Swivel Base Plate from the back and attach it to the pedestal face plate using the enclosed screws. Re-attach the cradle using the center screw.



STEP 4 OF 8

If you prefer NOT to use the Tilt-Swivel remove it by undoing the four screws on the face of the cradle. Then mount the cradle directly to the pedestal. (screws for mounting the cradle directly are not included and will need to be obtained separately)



STEP 5 OF 8

Inserting the Tablet:

Align the bottom of the tablet with the docking connector for the tablet. Allow the tablet to seat to the bottom of the holder.



STEP 6 OF 8

Locking the Tablet:

Press the top of the tablet to snap the top support into place.

Slide the key lock down over the tablet and press the center pin to lock the tablet into the cradle.



STEP 7 OF 8

Unlocking the Tablet:

To unlock the sliding lock, insert the key and turn until the center pin pops out. Slide the lock up and past the edge of the tablet to allow clearance for removal. Using a thumb or additional hand, slightly lift the top support up and pull the tablet towards you.



STEP 8 OF 8

Removing the Tablet:

Once free from the top support, lift up and away from the bottom of the holder to free the tablet.
