STEP 1 OF 4

Press the thin end of one of the enclosed gap openers into the gap between the climate control panel and its surrounding panel frame, to widen the gap. Peel off the cover of adhesive tape on the ProClip. Note: The adhesive tape does not leave any marks or damage the dashboard, and is easy to remove. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position, or if vertically positioned; the P in ProClip is at the top. Hold the curved edge on the lower part of the ProClip in a 45 degree angle towards the dashboard.



STEP 2 OF 4

Press the curved edge on the lower part of the ProClip into the gap next to the gap opener. Pull out the gap opener.



STEP 3 OF 4

Press both gap openers into the gap on top of the dashboard. Flip the ProClip forward and push firmly forward on the upper part of the face plate so the angled edge on the upper part of the ProClip goes into the seam/gap between the gap openers. Push until you see or hear/feel it click into place. Pull out the gap openers.



STEP 4 OF 4

The ProClip Mount is in place.

Returns
