STEP 1 OF 4

Press the thin end of the enclosed gap openers into the seam above the air vent between the vent frame and the padded upper part of the dash. To widen the gap. Peel off the cover of adhesive tape on the ProClip.

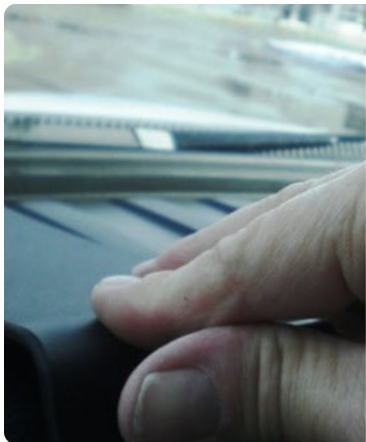
Note: The adhesive tape does not leave any marks or damage the dashboard, and is easy to remove.



STEP 2 OF 4

Place the ProClip in your hand so the ProClip label (sticker) is in an upright position.

Press the angled edge on the lower part of the ProClip into the gap between the gap openers.



STEP 3 OF 4

With one hand, press forward on the faceplate of the ProClip (Keeping the lower angled edge into the seam.). With your other hand, press downward on the forward most hooked edge of the ProClip. Flex the ProClip forward and downward. Hook the forward edge of the ProClip over the panel in the vent area. Pull out the gap openers.

This is a very tightly fitting mount and will take some pressure to attach or hook the ProClip onto the seam in the front vent.



STEP 4 OF 4

The ProClip Mount is in place.
