STEP 1 OF 4

Clean the area where the ProClip will be attached. Insert the thin edge of the gap opener into the seam separating the two dash top panels, to open the gap.



STEP 2 OF 4

Peel off the cover of adhesive tape on the ProClip. Note: The adhesive tape does not leave any marks or damage the dashboard, and it is easy to remove. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position, or if vertically positioned; the P in ProClip is at the top.

Press the angled edge on the upper part of the ProClip into the seam/gap next to the gap opener.



STEP 3 OF 4

Press down on the face plate of the mount to flex the lower edge into the seam between the console frame and the frame around the display.



STEP 4 OF 4

The ProClip Mount is in place.
