STEP 1 OF 4

Attaching the extension plate:

Press a screwdriver (Philips) firmly through the pre-drilled holes in the extension plate to open them up. Place the extension plate over the matching holes in your mounting bracket. Attach the extension plate by using the self-tapping screws. Note: The machine screws with nuts are for mounts made of metal with large holes.



STEP 2 OF 4

Attaching a holder to the extension plate:

Attach the base plate from the holders tilt swivel to the extension plate with the enclosed screws in the holder packaging. (TomTom Holder with tilt swivel shown in pictures)



STEP 3 OF 4

Attaching a holder to the extension plate:

Attach your holder onto the extension plate. (see separate instruction enclosed with the holder)



STEP 4 OF 4

The extension plate with holder and device in place. The device shown in the picture is a TomTom XL navigation unit.

Returns
