STEP 1 OF 4

Place the Vehicle Mount Adapter over the matching holes in the ProClip Vehicle Mount (demo ProClip mount shown in picture) or any other mounting bracket you may have and attach it with the applicable screws.

This Vehicle Mount Adapter fits a variety of navigation and other suction cup ball mount holders of different designs; however the principal of the installation is the same

STEP 3 OF 4

If your TomTom cradle is attached to a windshield suction cup mount, pull it off the ball and press it onto the ball of the Vehicle Mount Adapter. If you have attached the cradle, then attach the device onto the cradle and adjust it to desired position.



STEP 4 OF 4

The original cradle is on the ball mount. Attach your power cable to the original TomTom dock in the back.
