STEP 1 OF 4

Use the included hardware to create the desired width for the mount to attach. Use four bolts and the two hex couplers for wider frames. Keeping the two plates parallel, tighten one side and then the other as you fasten the mount onto the frame. Use two bolts with the washers and locking nuts for narrower frames.



STEP 2 OF 4

Before attaching the pedestal mount place the round base with large teeth onto the Forklift Clamp Mount hole pattern. Angle it to desired position, then attach it with applicable screws/ hardware.



STEP 3 OF 4

Adjust the arm based on the desired position of the device.
Securely tighten the wingnuts to lock the arm in place.



STEP 4 OF 4

Angle the base with the small teeth to desired viewing position and firmly tighten the wing nut. Device cradle can then be attached to the face.
