STEP 1 OF 4

Use the included hardware to create the desired width for the mount to attach. Keeping the two plates parallel, tighten one side and then the other as you fasten the mount onto the frame. Use four bolts and the two hex couplers for wider frames. Use two bolts with the washers and locking nuts for narrower frames.



STEP 2 OF 4

Use the lower wingnut to adjust the pedestal by tilting and swiveling. Securely tighten the wingnut to lock the pedestal in place.



STEP 3 OF 4

Use the upper wingnut to adjust the pedestal face plate by tilting and swiveling. Securely tighten the wingnut to lock the faceplate into the desired position.



STEP 4 OF 4

Device cradle can then be attached to the faceplate.
