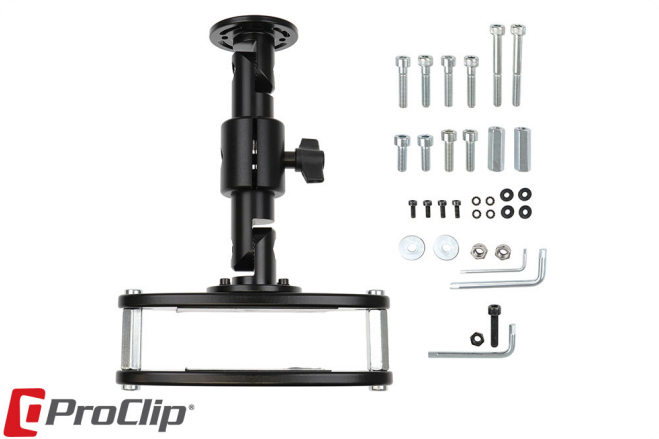

STEP 1 OF 8

#1 and #2 Round Bases

This product fits the Heavy-Duty Forklift and Pedestal mounts from ProClip. The small teeth match a #1 to a #2 to allow for a perfectly straight fit.



STEP 2 OF 8

Swiveling Center Section:

The center wingnut can be loosened to allow both pedestal bases to be independently rotated to get the plates to face the exact position desired. Simply tighten the wing nut after the adjustment.

To adjust the angle of the top and bottom plate, loosen the bolt with the included Allen wrench.

This allows adjustment to all 3 axis to achieve the exact angle and position desired.



STEP 3 OF 8

Locknut Replacement

This product comes with lock washers and wingnuts allow this to be locked into a specific position, or provide easy adjustment after being installed.

Simply remove the wing nut or lock nut and replace with the alternative to make each of the adjustment points function as desired.



STEP 4 OF 8

Highly Adjustable and Durable:

This product can achieve virtually any angle that a typical ball mount system can but provides additional strength and rigidity where needed.



STEP 5 OF 8

Attach the Clamp

This forklift mount includes a clamp that can accommodate any rectangular surface up to 5" x 5.125". Using the included fasteners, determine which screws will be required to span the width needed.

Note: Ensure the coupling nut or bolts contact both sides of the bar to prevent them from turning in the plate and ensuring they do not loosen over time.



STEP 6 OF 8

Attach Pedestal Base:

Attach one side of the pedestal base to the clamp. Either side can be attached and will not result in any difference in adjustment. **Note:** The clamp features a circular pattern of M4 holes to allow positioning as close to the desired angle as possible. Attach the base plate with the included M4 fasteners and lock washers.



STEP 7 OF 8

Attach Swivel Section:

Adjust the arm based on the desired position of the device.
Securely tighten the wingnuts to lock the arm in place.



STEP 8 OF 8

Installation Complete:

This completes the installation of the forklift mount. Note that the fasteners and Allen Wrenches included will allow you to complete this installation without any additional tools.
