STEP 1 OF 6

Mounting:

This mount fits any AMPS compatible forklift, vehicle, cart or pedestal mount. It includes the fasteners needed to attach to any compatible mount.



STEP 2 OF 6

Install Desktop Foot:

Fit the foot plate on the back of the plate. Note that a printer mount may be placed on top of this same hole pattern and attached to this roller mount. Attach using the included fasteners to set the foot.



STEP 3 OF 6

Printer Mount Options:

This mount is designed to work with multiple options of ProClip printer mounts that will attach to the same AMPS pattern shown here.



STEP 4 OF 6

Attach Adhesive Feet

Attach the included non-scratch non-slip adhesive pads to the foot to prevent the mount from sliding or scratching desktop surfaces.



STEP 5 OF 6

Attach Adhesive Feet

Attach the included non-scratch non-slip adhesive pads to the back metal corners to prevent the mount from sliding or scratching desktop surfaces.



STEP 6 OF 6

Print Media:

Fits media up to 4 inches wide and 8 inch diameter. The roller pin itself is .47 Inches Across (12mm).

Printer mount works with quick release power dock.

Returns
