## STEP 1 OF 4

### Attach the Printer Plate

Place the printer plate over the back of the printer. This plate supports both the Direct Thermal and Thermal Transfer versions of the printer. Using the small M3 screws, attach the plate to the printer using the pre-drilled holes in the plate that match the model you are using.



## STEP 2 OF 4

### Mount the Quick Release Dock

This kit comes with sheet rock anchors and screws that allow the quick release dock to be mounted to any flat surface. Select the appropriate fasteners from the large screw pack to mount to your desired location.



## STEP 3 OF 4

### **Docking and Undocking**

Align the plate with the quick release dock and slide down until the release lever clicks over the male block.

To release the printer, press the release lever slightly and lift the printer up and out of the quick release dock.



## STEP 4 OF 4

### Fastener Packs

Please note that this product comes with several fastener packs.

The 2 smaller screw packs are for attaching the printer plate to the printer. Use 3 or 4 screws from the 2 smaller screw packs to attach the plate to the printer. The 4th screw is a spare for one model of printer. These screws are M3 size and are 10mm long.

The large screw pack is for attaching the mount to a wall or flat surface,
