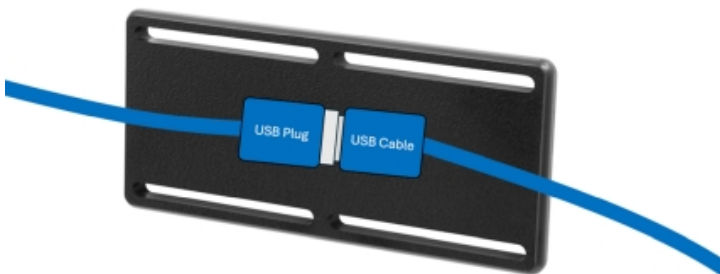

STEP 1 OF 4

Cable Retention Plate:

This product includes an optional cable retention plate and Zip Ties that allow cables of many sizes to be secured.

Place a connected cable in the center of the plate as illustrated above.

Small Zip Tie

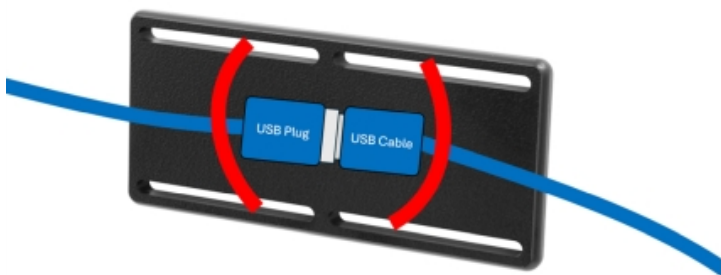


STEP 2 OF 4

Zip Tie Sizes:

Two sizes of Zip Tie are included in this package. The Red line in these illustrations represent the larger zip tie.

The orange line will represent the smaller zip ties.

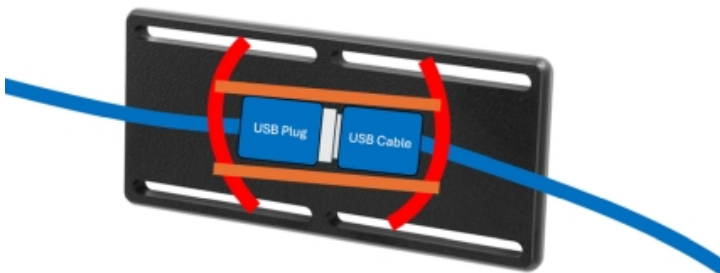


STEP 3 OF 4

Secure Cables to the Plate:

Using the larger Zip Ties, go around the base of each side of the cable connection on the strain relief for the cable.

Since the Zip Tie down over each cable to securely press it against the plate.



STEP 4 OF 4

Compress Cable Connection:

Using the smaller Zip Ties, go around the larger Zip Ties and sinch the small Zip Tie to compress the cables together, preventing them from shaking loose during normal use.
