



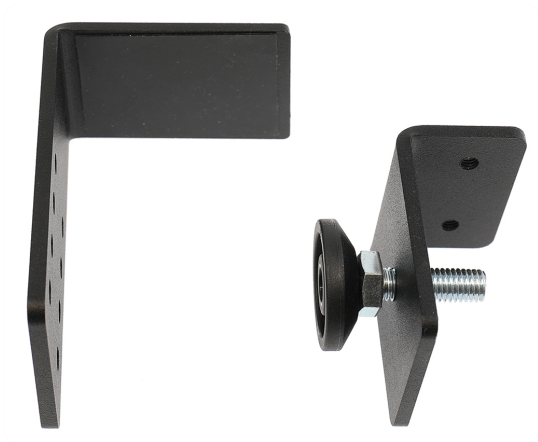

STEP 1 OF 6

Rubber Pad

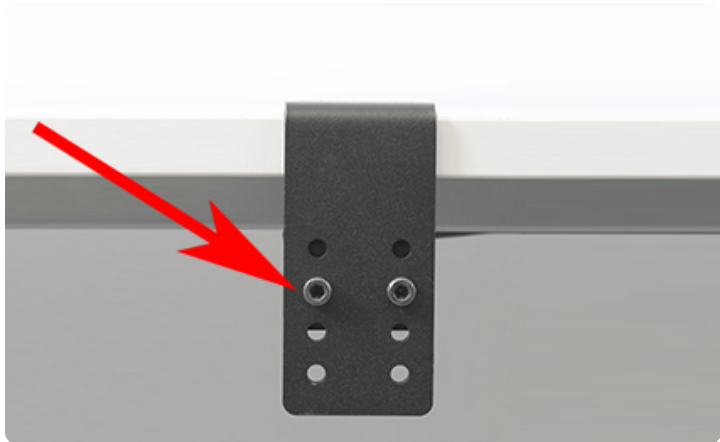
This clamp includes a rubber pad on the top to prevent it from scratching surfaces and also ensuring a firm grip on smooth surfaces.



STEP 2 OF 6

Tension Screw with Rubber Foot

The tension screw has a soft rubber foot to prevent scratching on attached surfaces. It can also be completely removed and inserted from the other side to increase the total thickness that can be accommodated in this clamp.



STEP 3 OF 6

Position the Bracket:

Place the main body of the bracket on the desired surface, ensuring the adjustable arm aligns with the edge of the surface.

Set the plate with the tension screw as close as possible by adjusting the tension screw and the included fasteners by hand to achieve the appropriate thickness.



STEP 4 OF 6

Secure the Screws:

Tighten the two plates together using the included Allen Wrench to ensure the plates are firmly attached. This will ensure a secure base for the clamp.



STEP 5 OF 6

Tighten the Tension Screw:

Use your fingers to tighten the tension screw as much as possible and then use the included Allen Wrench to tighten it firmly.

Warning:

Using powered tools is not recommended and can damage the surface being clamped to.



STEP 6 OF 6

AMPS Compatible Mount:

The clamp top features threaded M4 fastener slots. Use the included fasteners to attach any AMPS compatible pedestal or mount to the clamp. It is recommended you test the depth needed by hand before securing with the included Allen Wrench.

Warning:

Using fasteners that are too long can result in damage to the clamp surface.

Returns

All returns must be made within thirty (30) days of the delivery date and include proof of purchase, a copy of your original order, or invoice.
