## **STEP 1 OF 8**

### **ModTek Hard Case Frame:**

Place the frame face down on a flat surface to prepare it for installing the compatible tablet.

Note: Hard Cases are device specific and should only be used with the compatible tablet without any skin, case or screen protector installed.



## STEP 2 OF 8

### **Install the Tablet:**

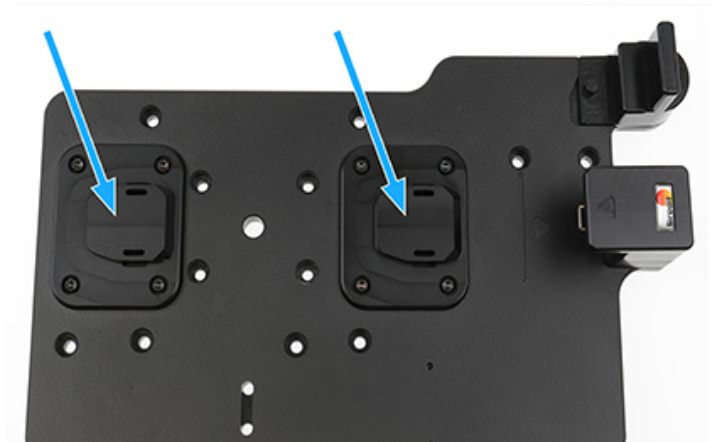
Place the tablet face down into the frame ensuring that it slides down into place. It should be slightly snug on the tablet sides of the tablet where it meets with the machined springs on the sides of the frame.



## STEP 3 OF 8

### Secure the Tablet:

Place the backplate over the tablet and secure it using the included 10 screws. These screws go through the backplate into the frame and you will need a T10 Torx screwdriver. These screws should only be fastened to finger tight. That is 0.6 N\*m or 5.3 inch-pounds of pressure when using a torque gauged tool.



## STEP 4 OF 8

### **Mount Points:**

This ModTek USB-C 3.1 Dock supports a variety of devices when installed in the ProClip ModTek Hard Case. The two mount points are used to align the tablet with the USB-C connector to ensure a perfect alignment and ensure the USB-C connection to the tablet does not create excessive wear.

Note: ModTek USB-C Dock Not Included. Must be purchased separately.



## STEP 5 OF 8

### **Mount Points:**

This ModTek USB-C 3.1 Dock supports a variety of devices when installed in the ProClip ModTek Hard Case. The two mount points are used to align the tablet with the USB-C connector to ensure a perfect alignment and ensure the USB-C connection to the tablet does not create excessive wear.

Note: ModTek USB-C Dock Not Included. Must be purchased separately.



## STEP 6 OF 8

### **Docking onto the USB-C:**

Once the Hard Case is aligned by engaging both mount points, smoothly slide the tablet onto the USB-C connector until you hear an audible click. The audible click confirms the case is properly docked. Note: Do not force the tablet onto the connector. If you feel significant resistance the case is not properly aligned. Remove it and ensure alignment on both mount points before continuing.



## STEP 7 OF 8

### **Releasing the Case:**

To release the case from the dock, use the quick release dial by turning it clockwise similar to turning a key. This will release the Hard Case and it will slide it slightly off the USB-C connector. Note: It is almost impossible to release the tablet without using the quick release lever and it should not be attempted.



## STEP 8 OF 8

### **Releasing from the Dock:**

Switch grip from the quick release dial and place your hand on top of the case. Continue to slide the case until you see the alignment line and then pull the case towards you.

## Returns
