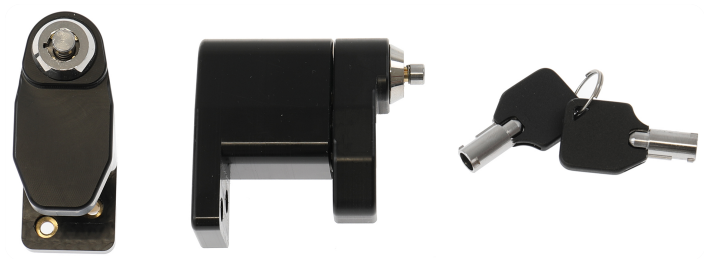

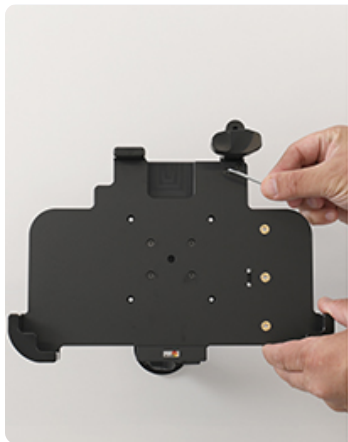

STEP 1 OF 4

Installing Key Lock

Loosen the screws on the locking module. Place the lock module with key lock behind the holder so that the screw fits into the holes. Tighten the screws so that the locking module is firmly in place.



STEP 2 OF 4

Adding Device into Holder

To insert the device into the holder: Place the lower part of the device into the holder and press forward on the upper part of the device so that it snaps into the holder. Slide the locking part down and press the button to lock.



STEP 3 OF 4

Removing Device from Holder

To remove the device from the holder: Unlock the lock with the supplied key. Slide the locking part upwards. Pull the top of the device out of the holder first, then you can lift the device up/out of the holder.



STEP 4 OF 4

Installation Complete
The holder fully assembled.
