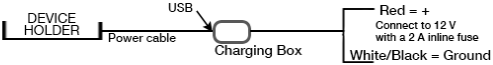

STEP 1 OF 4

Dual USB Power Ports

This Power Supply features 2 USB ports, each supplying power using various charging protocols.

65W USB-C Protocols: PPS, PD 3.0, PD 2.0, QC 3.0, QC 2.0, AFC, FCP, PE 2.0

18W USB-A Protocols QC 3.0, QC 2.0, AFC, FCP, HVSCP, PE 2.0, BC1.2, DCP, Apple 2.4A



STEP 2 OF 4

Connect 2-Pin Molex Cable

Once the power cable is connected to the vehicle by a certified installer, the 2-pin Molex cable can be connected to the power supply.

The 2-pin connector has a retention clip that will click into place when the cable is completely inserted, this will prevent the cable from vibrating loose.



STEP 3 OF 4

Insert the USB Cable

Connect your USB cable to the appropriate port for you device.

Note that both ports can be used simultaneously to provide charging to two different devices.



STEP 4 OF 4

USB Cable Retention

This power supply includes two zip ties to allow the USB cables to be secured and prevent them from vibrating loose.

To secure the USB cable, use the open slots closest to the port the USB cable is connected to and secure with one of the included zip ties.

Returns
