STEP 1 OF 4

To install the Quick Release Dock:

Place the Quick Release Dock onto your mounting surface.
(demo ProClip mount shown in photo)



STEP 2 OF 4

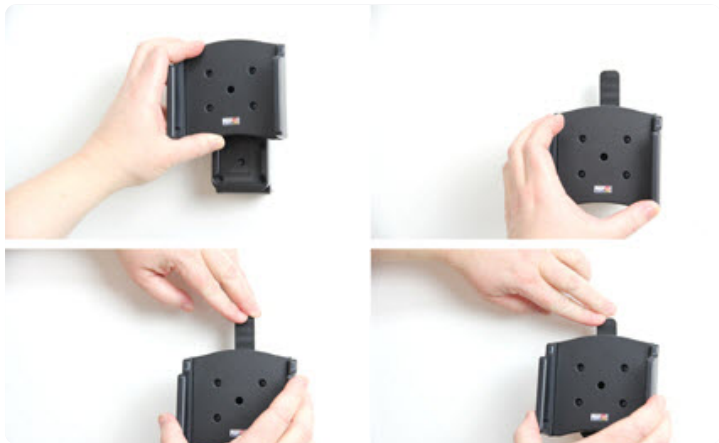
Attach the Quick Release Dock using the appropriate screws enclosed.



STEP 3 OF 4

Place the Quick Release Dock adapter Plate over the matching holes in the Holder and attach it with the enclosed screws.

Ensure the plate is oriented correctly for the position you want the holder to be in. i.e. vertical or horizontal.



STEP 4 OF 4

To insert a device holder:

Slide the male Quick Release Dock into the female Quick Release Dock until it clicks into place.

To remove the holder:

Press the release lever and slide the device upwards out of the clip.

Returns
