STEP 1 OF 4

Clean the area where the ProClip will attach. Place both rear parts of the mount into the dash top tray and hook the lower edges of the mount under the padded dash edge just above the two center vents.

The rear mount part with the face plate can go on the left or right side. Consider that placing the face plate onto the left side could block shifting.



STEP 2 OF 4

Center the front of the mount in the dash top tray and hook the two front edges of the mount over the dash top in the left and right defrost vent areas. Then let the front part of the mount lay onto the two rear parts of the mount.



STEP 3 OF 4

The dash top might need to be lifted a little for the two front edges to go all the way into the seam between the front of the dash top and the vent.



STEP 4 OF 4

Align the holes in the front part of the mount with the threaded holes in the rear parts of the mount and insert the 4 included screws through the front part of the mount and thread the screws into the two rear parts. Press the front and rear parts of the mount securely together before you tighten the screws all the way.

Returns
