#### **STEP 1 OF 8**

### Installing the Mount:

The mount comes in two halves that must be fastened together.

Making sure the smooth side of the plastic is facing down; fit the two halves together.



#### STEP 2 OF 8

### Installing the Mount:

The two halves of the mount will be held together by the top plate.

Fasten the top plate onto the mount using the included screws and Allen key.



#### **STEP 3 OF 8**

#### Installing the Mount:

Clean the area where the ProClip will attach. Remove the cover from the adhesive tape on the ProClip. Note: The adhesive tape does not leave any marks or damage the dashboard, and is easy to remove.

Press the thin angled edge on the forward part of the ProClip into the seam between the top part of the dash and the inner part of the defroster vent.



#### STEP 4 OF 8

#### The ProClip Mount is in place.

With your fingers behind the face plate pull the ProClip so it flexes towards you. Hook the thick angled edge on the back side of the ProClip around the dash edge and into the top of the air vent opening.

For installation of the optional extension plate, see reverse.

## **Installing the Optional Extension:**

Use the included self-tapping screws to attach the extension plate to the mount face.
