STEP 1 OF 4

Press the thin end of the enclosed gap openers into the gap between the frame around the upper center vents and the information screen panel behind the frame, to widen the gap. Start at the corner and work towards the center until the gap opens in the center.

Remove the cover from the adhesive tape on the ProClip. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position.



STEP 2 OF 4

Insert the top angled edge (Edge with two tabs.) of the ProClip all the way into the open seam between the gap openers.

NOTICE: The ProClip will only attach onto a few locations in the upper seam. Make sure both tabs go all the way into the upper seam. If both tabs do not go all the way into the seam, move the ProClip to the right or left until both tabs go all the way into the seams. Tabs that do not go all the way into the seam have a strong possibility of breaking.



STEP 3 OF 4

Pull out the gap openers in the upper seam and insert one gap opener into the seam between the frame around the vents and the radio, to widen the lower gap. (Models with a navigation/information screen will not need to insert a lower gap opener.)

NOTICE: When the top of the mount is in place, the bottom of the mount might appear to be 3/4 inch too short. It should look too small because the mount is designed to fit tight. The mount will flex down into place.



STEP 4 OF 4

Place your fingers behind the faceplate and flex the lower angled edge of the ProClip into the seam next to the gap opener.

Pull out the gap opener.

Note: The adhesive tape does not leave any marks or damage the dashboard, and is easy to remove.

Returns
