STEP 1 OF 8

Included Fasteners:

This mount kit includes fasteners for attaching the plate to the printer. It also includes fasteners for attaching the quick release dock to an appropriate pedestal or mount (Not included). Note that the smaller M3 fasteners are to be used with the printer.



STEP 2 OF 8

Mounting the Printer:

This printer mounting plate is designed to fit the Zebra ZD420 and ZQ620 printers. The mounting holes for the Direct Transfer version and the Thermal Transfer version are slightly different. This plate accommodates both.

Both printers are mounted with the M3 x 8MM fasteners that are included. If your printer only uses 3 screws, 1 will be unused and can be saved or discarded.

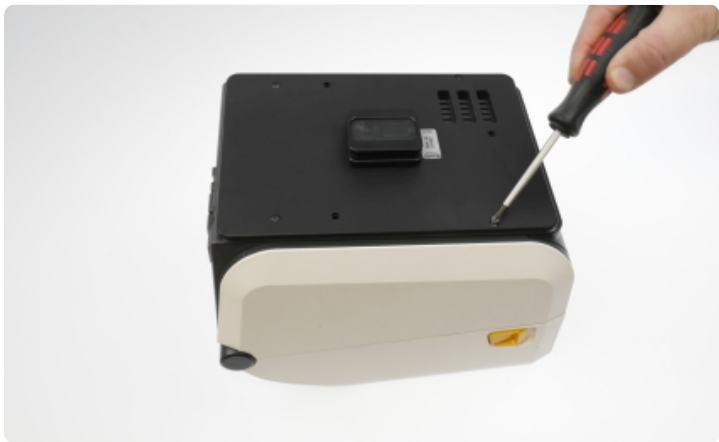


STEP 3 OF 8

Align the Printer Plate:

To determine how many of the M3 x 8MM fasteners will be needed, flip the printer over and match the hole pattern to the correct printer.

This plate is designed with an airflow channel to ensure the printer vent is not covered. Align the air channel with the vent on the printer, and then lay the plate onto the printer.



STEP 4 OF 8

Mount the Printer Plate:

With the printer plate aligned, place an M3 fastener into the plate and then fasten to the bottom of the printer using the included Allen wrench.

Note: You may only use 3 of the M3 fasteners depending on the model of printer you are mounting.



STEP 5 OF 8

To mount the Quick Release Dock:

Attach the base plate to any AMPS compatible mount using the included fasteners. (Demonstration pedestal not included.)



STEP 6 OF 8

Docking the Printer:

Insert the printer into the dock by aligning the male block and sliding down. The release lever will click when the dock is in place.



STEP 7 OF 8

Locking the Printer:

Press the center pin engage the lock. This prevents the release lever from moving and keeps the printer secured on the quick release dock until unlocked.



STEP 8 OF 8

Un-Locking the Printer:

Turn the key until the center pin pops out. Press the release tab on the dock slightly and slide the printer up and out.
