## STEP 1 OF 4

### **Remove the base plate from the holder:**

Using a standard Phillips screwdriver, completely loosen the center screw of the holder. The screw will not come out and will feel like it is just spinning.

Using light force, pull the base plate away from the back of the holder. This will separate the device holder from the base plate.



## STEP 2 OF 4

### **Attach the holder to a ProClip vehicle mount:**

Place the base plate over your desired mounting location on your ProClip vehicle mount. Attach the base plate using the included self-tapping screws with a standard Phillips screwdriver.

Place the holder onto the base plate and reattach it with the center screw. The center screw also controls the pivot; tighter for a firm hold and looser for easier rotation/angling of the holder.



## STEP 3 OF 4

### **Fit your device in the holder grooves:**

Slightly loosen the two smaller screws at the top and bottom of the holder with less than one full turn of a screwdriver. **Do not fully remove these screws.**

The holder arms can now be adjusted to fit your device.



## **STEP 4 OF 4**

### **Slide your device down into the holder grooves:**

Slide your device into the grooved slots and press the holder arms together, so your device is held in place. Carefully remove your device without changing the position of the side arms. Tighten the smaller screws to lock the holder arms into the correct position for your device.

## Returns
