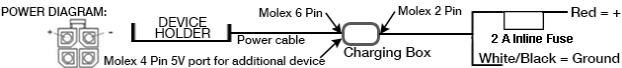

STEP 1 OF 4

To install the holder onto a mount:

Completely loosen **ONLY the one screw in the center** of the holder and pull

the swivel base plate away from the back of the holder. Place the Tilt-Swivel base plate over the matching holes in your mounting bracket and attach using the applicable screws.

Place the holder onto the Tilt-Swivel base plate and reattach it with the center screw. The center screw also controls the pivot, tighter for a firm hold and loose for easier rotation/angling of the holder.



STEP 2 OF 4

To insert the device:

Set the bottom of the device into the cradle then press the top into place. The upper arms will grip the device to keep it firmly in the holder. When the device is seated the pogo pins will connect and start charging.



STEP 3 OF 4

The remove the device:

Pull firmly on the top of the device to release it from the upper arms. Once the upper arms are released you can lift the device up and out of the cradle.



STEP 4 OF 4

Installation is complete:

Tilt or rotate the holder for best viewing angle.
