STEP 1 OF 4

Mounting the Holder

The holder has AMPS and VESA 75/100 hole patterns and can fit a wide range of pedestals, monitors and other mounts. Place the holder over the matching holes in the back plate of the holder. Attach the holder using the included fasteners.



STEP 2 OF 4

Docking the Tablet

Place the lower part of the tablet in the cradle, then press the upper part forwards so it snaps into place in the holder. The top lip of the holder will slide over the top of the tablet and hold the tablet in place.

Press the lock down over the top lip of the tablet. Depress the center pin to lock the tablet into place.



STEP 3 OF 4

Undocking the Tablet

Using the key, turn the lock until the center pin pops out. Slide the lock up past the top lip of the tablet.

Using a thumb, press up on the top lip of the holder and then pull forward on the top of the tablet.

Once clear of the top lip, lift up on the tablet to remove from the holder.



STEP 4 OF 4

Installation Complete

The holder is now in place. This holder has open sides that accommodate the included hand straps for the ET51 8.4" with Integrated 1D/2D Barcode Scanner.

Returns
