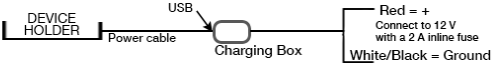

POWER DIAGRAM:

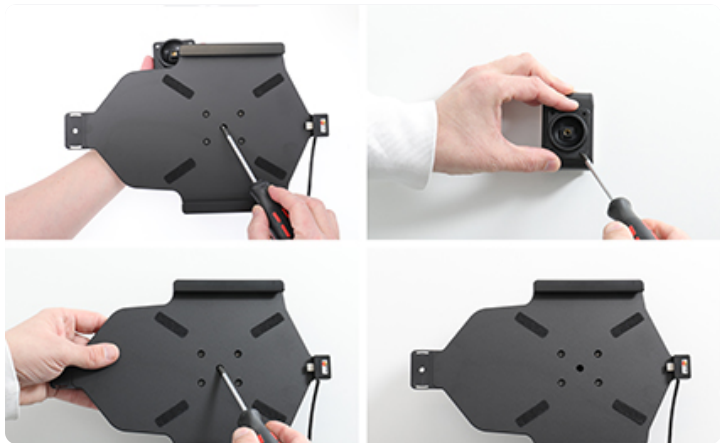

STEP 1 OF 4

Unscrew the screw in the center of the holder so you can remove the tilt swivel base plate on the back. Place the tilt swivel base plate over the matching holes in the face plate of your mounting bracket (ProClip demo mount shown in picture). Attach the base plate by using the screws enclosed. Place the Holder onto the tilt swivel base plate and attach it with the center screw. This screw also controls the pivot, tighter for a firm hold and loose for more (easier) angling/rotation of the Holder.



STEP 2 OF 4

To insert the tablet into the holder: Slide the tablet carefully into the holder. Attach the spring lock onto the left part of the holder.



STEP 3 OF 4

To remove the tablet from the holder: Remove the spring lock by firmly pulling it off of the holder. Slide the tablet carefully out of the holder.



STEP 4 OF 4

The holder and tablet is in place. Switch between portrait and landscape view by rotating the holder to desired position.

Returns
