## **STEP 1 OF 4**

Press the thin end of the enclosed gap opener into the seam/gap between the dashboard and the air vent panel frame, to widen the gap.



## **STEP 2 OF 4**

Peel off the cover of adhesive tape on the ProClip. Note: The adhesive tape does not leave any marks or damage the dashboard, and it is easy to remove. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position, or if vertically positioned; the P in ProClip is at the top. Flip the ProClip into an almost horizontal position (inside facing up) and press the angled edge on the lower part into the gap next to the gap opener. Pull out the gap opener.



### **STEP 3 OF 4**

Flip the ProClip upward towards the air vent. Press the thin end of the enclosed gap opener into the seam/gap between the dashboard and the air vent panel frame, to widen the gap. Then press firmly forward on the upper part of the ProClip so the grooved upper edge goes into the gap next to the gap opener. Press until you see, hear or feel the ProClip click into place. Pull out the gap opener.



## **STEP 4 OF 4**

The ProClip Mount is in place.

## Returns
