STEP 1 OF 4

Clean the area where the ProClip will attach. Insert the gap opener into the left seam between the frame around the left vent and the dash, to widen the gap.

Remove the cover from the adhesive tape on the ProClip. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position, or if vertically positioned; the P in ProClip is at the top.



STEP 2 OF 4

Insert the angled edge on the left side of the ProClip into the seam next to the gap opener. Remove the gap opener.



STEP 3 OF 4

Insert the gap opener into the right seam between the frame around the left vent and the dash, to widen the gap. NOTE: It

Insert the angled edge on the right side of the ProClip into the seam next to the gap opener. Remove the gap opener.

Note: The adhesive tape does not leave any marks or damage the dashboard, and is easy to remove.



STEP 4 OF 4

The ProClip Mount is in place.
