STEP 1 OF 4

Clean the area where the ProClip will attach. Insert the included gap opener into the seam between the upper left vent frame and padded dash above it, to widen the gap.

The adhesive tape cover must be removed.



STEP 2 OF 4

Place the ProClip in your hand so the ProClip label (sticker) is in an upright position. Insert the lower "S" shaped edge of the ProClip into the seam between the lower left vent panel and the panel that surrounds the traction control buttons.

Press in on the lower ProClip edge as you tip the ProClip upward to ensure the lower edge goes into the seam and behind the lower panel.



STEP 3 OF 4

Flex the ProClip upward and insert the upper angled edge into the seam next to the gap opener. Press down on the upper ProClip edge to make sure the tape sticks.

NOTE - The adhesive tape cover should be removed. The tape does not leave any marks or damage the interior, and is easy to remove.



STEP 4 OF 4

The ProClip is in place.

Returns
