STEP 1 OF 4

Clean the area where the ProClip will attach. The adhesive tape cover must be removed. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position. Hook the notched right edge of the ProClip onto the right side frame around the far left dash vent.



STEP 2 OF 4

Press the left side of the ProClip to the right and hook the left notched edge of the ProClip onto the left side of the vent.



STEP 3 OF 4

The ProClip is in place.

NOTE - The adhesive tape cover should be removed. The tape does not leave any marks or damage the interior, and is easy to remove.



STEP 4 OF 4

The ProClip is in place.
