## **STEP 1 OF 4**

Press the thin end of the enclosed gap opener into the gap/ seam between the console edge and the panel surrounding the gear shift, to widen the gap. Peel off the cover of adhesive tape on the ProClip. Note: The adhesive tape does not leave any marks or damage the dashboard, and it is easy to remove. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position, or if vertically positioned; the P in ProClip is at the top.



## **STEP 2 OF 4**

Press the angled edge on the left side of the ProClip into the gap next to the gap opener. Pull out the gap opener.



### **STEP 3 OF 4**

Press down on the top right side of the ProClip so it flexes downward and the angled edge hooks around the panel edge in the console sidewall. Then press down on top of the ProClip for best possible attachment of the adhesive tape. The ProClip is now in place as shown in the overview picture above.



## **STEP 4 OF 4**

The ProClip Mount is in place.

## Returns
