GAP OPENER

STEP 1 OF 4

Place/align the wide end of the enclosed gap opener with the edge of the panel surrounding the gear shift to create the right location for attaching the ProClip.



STEP 2 OF 4

Peel off the cover of adhesive tape on the ProClip. Note: The adhesive tape does not leave any marks or damage the dashboard, and is easy to remove. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position, or if vertically positioned; the P in ProClip is at the top.

Press/hook the angled edge on the left side of the ProClip into the seam between the shifter frame and the floor console upper panel edge in front of the gap opener.



STEP 3 OF 4

Press the thin end of the gap opener into the gap in the console sidewall next to the ProClip, to widen the gap.

Press down on the top right side of the ProClip so it flexes downward. The lower angled edge on the ProClip should hook into the gap next to the gap opener. Pull out the gap opener.



STEP 4 OF 4

The ProClip Mount is in place.

Returns
