STEP 1 OF 4

Note: You can place the mount within the length of the console sidewall regardless of where the cup holder is placed. Peel off the cover of adhesive tape on the ProClip. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position, or if vertically positioned; the P in ProClip is at the top. Place the angled edge on the right side of the ProClip over the console edge.

STEP 2 OF 4

Press firmly down on the left side of the ProClip so it flexes down and the angled edge hooks into the gap in the sidewall.

Note: The adhesive tape does not leave any marks or damage the dashboard, and is easy to remove.
