STEP 1 OF 4

Peel off the cover of adhesive tape on the ProClip. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position, or if vertically positioned; the P in ProClip is at the top. Hook the lower angled edge of the ProClip under the console right side panel by the carpet.



STEP 2 OF 4

Insert the enclosed gap opener into the gap between the center console panel and the console side panel. Then with your fingers under the upper part of the ProClip, flex the upper angled edge over the top of the console top and place the angled edge on the left side of the ProClip and into the gap in the seam next to the gap opener. Using both hands will make it easier.



STEP 3 OF 4

Press down on the top of the angled edge of the ProClip to ensure it is all the way into the seam. The ProClip is in place.

Note: The cup holder cover/door will still slide freely open and closed.

Note: The adhesive tape does not leave any marks or damage the dashboard, and is easy to remove.



STEP 4 OF 4

The ProClip Mount is in place.
