GAP OPENER

STEP 1 OF 4

Peel off the cover of adhesive tape on the ProClip. Note: The adhesive tape does not leave any marks or damage the dashboard, and is easy to remove. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position, or if vertically positioned; the P in ProClip is at the top.

Press the angled edge on the left side of the ProClip into the gap between the console edge and the center console panel.



STEP 2 OF 4

Press the thin end of the enclosed gap opener into the gap between the console edge and the carpet next to the ProClip, to widen the gap.

Press down on top of the ProCip so it flexes downward and the angled edge on the lower part of the ProClip hooks around the console edge by the carpet.

Pull out the gap opener.
