STEP 1 OF 4

Peel off the cover of adhesive tape on the ProClip. Note: The adhesive tape does not leave any marks or damage the dashboard, and is easy to remove. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position, or if vertically positioned; the P in ProClip is at the top. Place the angled edge on the left side of the ProClip over the console edge. (See photos for location.)



STEP 2 OF 4

Press down on top of the ProCip so it flexes downward and the angled edge on the lower part of the ProClip hooks around the lower console edge. Push on the lower part of the ProClip with your finger to make sure the angled edge is hooked all way around.
