STEP 1 OF 4

Press the thin end of one of the enclosed gap openers into the gap between the trim and the padded console part of the console, to widen the gap. (See photo for location.)



STEP 2 OF 4

Place the ProClip in your hand so the ProClip label (sticker) is in an upright position, or if vertically positioned; the P in ProClip is at the top.

Press the angled edge on the lower part of the ProClip into the gap next to the gap opener. Pull out the gap opener.



STEP 3 OF 4

On each side of the ProClip, press the thin end of each gap opener into the gap between the compartment area sidewall and the padded console edge, to widen the gap.

With your hand on the right side of the ProClip, press firmly towards the left so the ProClip flexes to the left and the curved left edge hooks into the gap between the gap openers. Pull out the gap openers.



STEP 4 OF 4

The ProClip Mount is in place.
