GAP OPENER

STEP 1 OF 4

Clean the area where the ProClip will attach.

Press the thin end of the enclosed gap opener into the gap between the right side of the cup holder frame and the center console side panel, to widen the gap.

The adhesive tape cover must be removed.



STEP 2 OF 4

Place the ProClip in your hand so the ProClip label (sticker) is in an upright position.

Press the left edge of the ProClip into the seam next to the gap opener.

Pull out the gap opener.



STEP 3 OF 4

Insert the gap opener between the bottom of the right center console panel and the carpet below it.

NOTE - The tape does not leave any marks or damage the dashboard, and is easy to remove.



STEP 4 OF 4

Press down on the right side of the ProClip and, at the same time, press in on the bottom of the ProClip to hook the bottom edge of the ProClip under the console panel.

Pull out the gap opener.

Returns
