STEP 1 OF 6

Install the Upper Lip:

Hook the top lip of the mount over the side of the console forward of the cup holders.



STEP 2 OF 6

Install the Lower Lip:

Press down on the top of the mount while pressing in on the bottom until the lower lip clips under the console trim.



STEP 3 OF 6

Install the Lower Lip:

Press in and up on the bottom of the mount to ensure the lip is completely seated.



STEP 4 OF 6

Install the Face Plate:

Place the locking washer into the recess on top of the riser block.



STEP 5 OF 6

Install the Face Plate:

Place the faceplate over the riser and angle as desired. Secure the faceplate to the mount using the included machine screw. The faceplate may be installed for use by the driver or passenger.



STEP 6 OF 6

The mount is in place.
