## STEP 1 OF 6

### **Install the Lower Lip:**

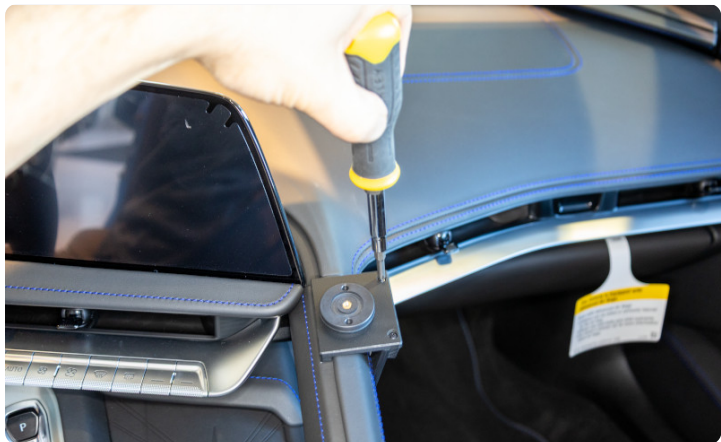
Locate the trim seam under the console rail. Gently work the lower lip of the mount into the seam. Slide the mount to the upper most position on the rail.



## **STEP 2 OF 6**

### **Install the Upper Lip:**

Rest the upper lip against the raised edge of the rail trim. Align the screw holes of the upper and lower sections of the mount.



## **STEP 3 OF 6**

### **Install the Upper Lip:**

Secure the upper and lower sections of the mount together with the included screws.



## **STEP 4 OF 6**

### **Install the Faceplate:**

Place the locking washer into the recess on top of the swivel plate.



## **STEP 5 OF 6**

### **Install the Faceplate:**

Place the faceplate on the swivel plate and angle as desired. Secure the faceplate to the mount using the included machine screw. The faceplate may be installed for use by the driver or passenger.



## **STEP 6 OF 6**

**The mount is in place.**
