## **STEP 1 OF 4**

The ProClip can be attached within the with of the air vents/ stereo. Peel off the cover of adhesive tape on the ProClip.

Note: The adhesive tape does not leave any marks or damage the dashboard, and it is easy to remove. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position, or if vertically positioned; the P in ProClip is at the top. Press the curved edge on the lower part of the ProClip into the gap between the dashboard ledge and the panel frame.



## **STEP 2 OF 4**

Press forward and upwards on the upper part of the ProClip so the grooved edge goes into the gap between the panel frame and the padded dashboard. Press until you see or hear/feel it clip or snap into place.



### **STEP 3 OF 4**

The ProClip is now in place as shown here and in the overview picture.



## **STEP 4 OF 4**

The ProClip Mount is in place.
