GAP OPENER

STEP 1 OF 4

Press the thick end of the enclosed gap openers into the gap between the dashboard overhang and the dashboard center panel, to widen the gap. Press forward on the right side of the air vent.



STEP 2 OF 4

Peel off the cover of adhesive tape on the ProClip. Note: The adhesive tape does not leave any marks or damage the dashboard, and it is easy to remove. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position, or if vertically positioned; the P in ProClip is at the top. Press the angled edge on the upper part of the ProClip into the gap between the gap openers. Press until you see or hear/feel it click into place.



STEP 3 OF 4

Align the left vertical part behind the face plate of the ProClip with the air vent edge. Then press firmly forward on the left side of the ProClip so the grooved edge hooks around the air vent edge. Press until you see or hear/feel it click into place.



STEP 4 OF 4

Press firmly forward on the lower right side of the ProClip so the grooved edge hooks around the panel edge surrounding the climate control panel. Press until you see or hear/feel it click into place. Adjust the air vent and pull out the gap openers. The ProClip is now in place as shown in the overview picture above.

Returns
