GAP OPENER

STEP 1 OF 4

Press the thin end of the enclosed gap opener into the gap between the stereo and the surrounding panel frame to widen the gap.



STEP 2 OF 4

Press the grooved edge on the lower part of the ProClip onto the gap next to the gap opener. Press until you see or hear/feel it snaps into place. Pull out the gap opener and slide the ProClip all the way to the left.



STEP 3 OF 4

Pull the upper part of the ProClip upwards, and press the grooved edge into the gap between the panel frame and the padded dashboard. Press until you see or hear/feel it snaps into place.



STEP 4 OF 4

The ProClip Mount is in place.
