### **STEP 1 OF 4**

Peel off the cover of adhesive tape on the ProClip. Press the angled edge on the left side of the ProClip into the gap between the console wall and the padded edge.



## STEP 2 OF 4

Flip the ProClip over the padded console edge, towards the stereo.



#### STEP 3 OF 4

Place your fingers on the left side of the ProClip and press the ProClip towards the stereo so the angled edge on the right side of the ProClip hooks into the gap between the stereo and the surrounding panel frame. SEE ARROW IN PICTURE. Press forward on the right side of the ProClip to make sure the angled edge is all the way into the gap.

Make sure you are attaching the ProClip into the correct seam on the right.

(Between the radio and the frame around the radio.)

The ProClip Mount is in place.
