GAP OPENER

STEP 1 OF 4

Press the thin end of the enclosed gap opener into the gap between the center console frame and the coin box frame, to widen the gap. Peel off the cover of the adhesive tape on the ProClip.



STEP 2 OF 4

Press the curved edge on the left side of the ProClip into the gap below the gap opener. Flip the ProClip towards the right so the curved edge on the left side hooks behind the coin box frame. Pull out the gap opener.



STEP 3 OF 4

Press the thin end of the gap opener into the gap in the center console sidewall, to widen it. Press firmly forward on the right side of the ProClip so the angled edge snaps into the gap above the gap opener. Pull out the gap opener



STEP 4 OF 4

The ProClip Mount is in place.
