## **STEP 1 OF 4**

Press the thin end of the enclosed gap opener into the gap between the center console panel frame and the air vent panel frame, to widen the gap. Peel off the cover of the adhesive tape on the ProClip. Press the curved edge on the right side of the ProClip into the gap below the gap opener. Pull out the gap opener.



## **STEP 2 OF 4**

Push/Slide the ProClip downwards until it stops. (Aligned with the buttons as shown in picture)



### **STEP 3 OF 4**

Press the opener into the gap between the padded part of the dashboard and the air vent panel frame. Press firmly forward on the left side of the ProClip so the angled edge goes into the gap below the gap opener. Press until you see or hear/feel it snaps into place. Pull out the gap opener.



## **STEP 4 OF 4**

The ProClip Mount is in place.

## Returns
