STEP 1 OF 4

Press the thin end of the enclosed gap openers into the gap between the air vent panel frame and the stereo, to widen the gap.



STEP 2 OF 4

Peel off the cover of adhesive tape on the ProClip. Note: The adhesive tape does not leave any marks or damage the dashboard, and it is easy to remove. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position, or if vertically positioned; the P in ProClip is at the top. Press the grooved edge on the lower part of the ProClip into the gap between the gap openers. Pull out the gap openers.



STEP 3 OF 4

Press firmly down on top of the ProClip and insert the thin end, with adhesive tape, into the air vent so it is attaching to the upper inside part of the air vent.



STEP 4 OF 4

The ProClip Mount is in place.
