STEP 1 OF 4

Attention! This ProClip consists of two parts. Part 1 - ProClip attaching part (the smallest part) and Part 2 is the ProClip face plate. Press the thin end of one enclosed gap opener into the gap between the center console panel frame and the padded part of the dashboard, to widen the gap. Press the second gap opener into the gap at the lower corner. Push both gap openers in until they stop. Peel off the cover of the adhesive tape on Part 1.



STEP 2 OF 4

Align the top of Part 1 with the panel line above the temperature controls to the left of the opened gap (notice the bold line in the left photo) Or measure 5 1/8 down from the top of the seam.

Press the angled edges firmly into the gap and at the same time rotate Part 1 to the left until you see or hear/feel it clip into place behind the panel. Don't press the tape towards the console edge yet. First, slide Part 1 downwards until it stops. Then press Part 1 towards the console edge so the adhesive tape attaches. Pull out the gap openers.



STEP 3 OF 4

Press a screwdriver (Philips) firmly through the predrilled holes in Part 2 to open the holes. Peel off the cover of the adhesive tape on Part 2. Place Part 2 onto Part 1 so the holes match and the adhesive tape on Part 2 is on the left side. Do not attach the tape to the center console panel frame yet. First, screw Part 2 onto Part 1 using the enclosed screws. Right before you tighten the screws press the ProClip to the right with your thumb for optimal adjustment of the mount. Hold it in that position and tighten the screws. The ProClip is in place.



STEP 4 OF 4

The ProClip Mount is in place.
