DO NOT attach anything to the mount face plate until after installing the mount to the dashboard. Doing so makes it more difficult to install the mount to the dash.

STEP 1 OF 4

Attention! This ProClip consists of two parts. Part 1 - ProClip attaching part (the smallest part) and Part 2 - ProClip face plate.

Press the thin end of the enclosed gap opener into the gap between the center console panel frame and the console edge, to widen the gap. Peel off the cover of the adhesive tape on Part 1. Place the angled edge of Part 1 against the gap above the gap opener. Press the angled edge firmly into the gap.



STEP 2 OF 4

Bend Part 1 to the right so the angled edge hooks behind the center console panel, and the adhesive tape on the right side attaches to the console edge. Pull out the gap opener.



STEP 3 OF 4

Press a screwdriver (Philips) firmly through the predrilled holes in Part 2 to open them up. Peel off the cover of the adhesive tape on Part 2. Place Part 2 onto Part 1 so the holes match and the adhesive tape on Part 2 is on the left side. Do not attach the tape to the center console panel frame yet. Screw Part 2 onto Part 1 using the enclosed screws. Right before you tighten the screws press the ProClip to the right with your thumb for optimal adjustment of the mount. Hold it in that position and tighten the screws.



STEP 4 OF 4

The ProClip Mount is in place.
